




This document describes the operation and characteristics of Foldable Dispenser Cart SDC 03 and Foldable Dispenser Cart SDC 03 Plus (hereinafter "cart" or "cart SDC 03" or "cart SDC 03 Plus"). It contains important information about how to use the cart properly and how to increase its reliability and life. This document must always be available in the place where the carts are used. Keep it together with the cart at all times. The operator is responsible for using the carts safely and in compliance with the instructions in this manual, which applies to any third persons as well. If you have any doubts about the correct use of the carts, please contact the manufacturer or an authorized dealer.

Foldable Dispenser Cart is intended for use wherever it is necessary to apply loose sorbents in liquidation of leakage of undesirable or dangerous liquids (eg. petroleum products, liquid chemicals). The cart is portable and is designed for all commonly used types of sorbents – from heavy minerals to light granules, including crushed biological fibrous materials – up to a grain size of 8 mm. It allows you to dose the spreading density and select the track width up to 440 mm.

## **Specification of types of Foldable Dispenser Carts**

#### Common signs of Foldable Dispenser Carts SDC 03 and SDC 03 Plus


- 1. The carts are designed as fast solution for emergency situations. They are intended for removal of hazardous substances leaking into the environment.
- The construction of the cart is collapsible, thanks to which the cart is especially suitable for use on the road, eg. by rescue and emergency units.
- 3. They are made of a chemically resistant material see Chemical resistance certificate, p. 7.
- 4. The carts have adjustable handle ranging from 750 to 1300 mm. The handle has a stop preventing the full extension. It is made of AISI 304 stainless steel with plastic coated grip.
- 5. The maximum filling capacity of the hopper is 65l.
- 6. The density of the sorbent application and the track width (maximum 440 mm) can be regulated by means of the sorbent spreading cover.
- 7. Adjustable anchor ensures stability for reliable filling of the cart's hopper without any help of other person. In hidden position it is only 190 mm, which is also the width of the cart folded for storage.
- 8. Hinged side brace ensures safe opening of the hopper or its folding to minimal dimensions.
- 9. Strength materials, stainless steels, solid polyurethane, industrial bearings, durable surface treatment and treatments against dust damage to the mechanism are used in production.
- 10. Reinforcement of parts subject to stress.
- 11. The range of temperatures for the use of the carts is from -30  $^{\circ}$ C to +70  $^{\circ}$ C.

## Design differences of the carts SDC 03 and SDC 03 Plus

#### **SDC 03**

- 1. Adjustable anchor **manually operated** to adjust the anchor, it is necessary to manually loosen and extend the anchor and then tighten the adjusting nuts on the bottom of the cart.
- Profiled spreader plate manually operated adjustment and securing is done manually using adjusting nuts.
   The operator always adjusts the track width and the amount of sorbent manually. He also closes the sorbent cover manually after finishing work.






#### SDC 03 Plus

#### To increase operator comfort, the product can be supplemented with these improvements:

- Adjustable magnetic anchor allows control by the toe of the shoe and effortlessly ensures a quickly
  active position of the support. The advantage is easy handling without the need to manually lock the
  adjustable nuts on the bottom of the cart. The anchor can be moved to the storage position again by simply
  moving the anchor back with the toe of the shoe.
- 2. Magnetic spreader plate with stops. The cover is adapted for control by the toe of the shoe. The magnets ensure its permanent position without the need to manually lock the adjustable nuts. In addition, it is supplemented with stops for setting the repeatable position of the cover during spreading. This is very prompt and convenient for the operator. After setting the stops to the set sorbent spreading density and track width, the cover can be moved to the standby position by simply moving the cover up or down with the toe of the shoe.

**Recommendation – we recommend the magnetic** cover especially for applications of very loose sorbents, which are characterized by spontaneous spillage even in the rest position of the cart and during transport to places outside the application of the sorbent. In these cases, it is appropriate and expedient to close the cover completely with a foot and then open it before sprinkling. The stops always ensure the same position of the spreading cover.





## Instructions for use of the cart



When using the cart, observe these instructions as well as all the safety notices herein.



## Handling instructions and safety warnings

- The cart is a tool for spreading any kind of granular sorbents up to 8 mm grain size from heavy to light mineral
  granules, including shredded fibrous biological materials (usage of some very light fibrous materials consult
  with the supplier).
- 2. For operational use, dry sorbents can be left directly in the trolley. Eg. there, where it is appropriate to shorten the application time of the sorbent (chemical storage).
- 3. Attention! For the application of de-icing salt: Although the cart is preferably designed for even spreading of sorbents, it can also be used for the application of de-icing salt under certain conditions. Due to the fact that salt has specific properties that can damage the cart if used incorrectly (hygroscopic and chemically aggressive), the manufacturer cannot accept liability for damage if used for these purposes. If you still decide to use the cart for this purpose, make sure that the salt is dry and immediately after use clean thoroughly. Even small salt residues can cause corrosion on metal parts or seizure of bearings.
- 4. Do not put the product near fire or any other sources of heat.
- 5. Observe the safety measures for working with hazardous liquids and with substances harmful to the environment.
- 6. Make sure you observe any necessary precautions regarding personal safety, such as the use of protective equipment.

### Maintenance and storage

After use the product must be washed with proper neutralization detergent (in the case of aggressive substances) and lukewarm water or another suitable detergent. We recommend storing the cart folded in transport form to prevent damage when not in use. For long-term storage, place the product in a dry place out of the reach of UV radiation.
